The Rules

Photographers must enter only flower photographs. They can be a single or multiple flowers. Each photographer may submit up to 3 photographs. There is no entry fee and only one prize per entrant. All entries must be received by midnight, November 15, 2009. Winners will be announced in December 2009.

Photographs will NOT be returned. Please DO NOT send your only copy.

The Winners

Submitting Prints

Prints must be a minimum 4 x 6 inches and no larger than 8.5 x 11 inches. Photographs can be in color or black and white. Attach a label or write on the back of each print with your name, phone number, and title (type of flower). Do not write on the photo itself. If submitting multiple entries, number each print to match a corresponding entry form. Prints will not be returned.
